



Emergency Response Level : Precautionary Measures 緊急應變級別: 注意事項

1. In-Patient Admission / Out-Patient Arrangement 入院/門診診症安排

All patients admitted for inpatient service, day case, or outpatient procedures must provide a professional swab (e.g. Nasopharyngeal swab, Combined nasal and throat swab) Real-time PCR COVID-19 test report with a negative result within 48 hours upon admission. Patients who undergo the test in our hospital can enjoy a half-price discount on testing fees, which will not be refunded under any circumstances. Every inpatient is required to be tested again for COVID-19 every 7 days. (Effective on September 1, 2022)

所有住院、日間手術或日間中心病人，於入院時必須提供48小時內結果呈陰性的2019冠狀病毒病專業拭子檢測報告（例如：鼻咽拭子核酸或鼻腔和咽喉合併拭子核酸）。所有住院病人每隔7天須再次接受檢測。病人如於本院進行檢測，可享有檢測費半價優惠，不論任何情況下有關費用均不會退回。(2022年9月1日生效)

According to Centre of Health Protection's (CHP) instruction, our hospital is requested to make a report to the CHP for further investigation if patient who is found to have fulfilled the reporting criteria of identifying Coronavirus Disease 2019 (COVID-19). Patient will be referred to public hospitals for treatment and follow-up.

根據衛生防護中心指引，若病人出現符合呈報準則情況，醫院須向衛生防護中心呈報相關個案，並安排病人轉送公立醫院接受進一步檢查和治療。

- a) **Please ensure** that you **have NOT travelled out of Hong Kong within the last 14 days**; or **have NOT been** in close contact with a suspected/ confirmed case of COVID-19 **within the last 14 days**.
- b) **After the completion of mandatory quarantine**, we will help you re-schedule the admission /appointment date.
- c) **Exemption from Compulsory Quarantine Arrangement**
Individuals exempted from compulsory quarantine arrangement including crew members: If any patients who have travelled out of Hong Kong within the past 14 days show any suspected COVID-19 symptoms such as acute respiratory illness, they will be transferred to public hospitals for follow-up treatment if they meet the reporting standards.
- d) **Our Clinical Laboratory and Pathology is a designated institution recognised by the HKSAR Government to provide COVID-19 test. Nasopharyngeal Swab Test (1), Deep Throat Saliva Test and Antibody Test (2) are now available.**
- Only applicable for:
 - who **have NOT travelled out of Hong Kong** within the last 14 days
 - who **have NOT been** in close contact with a suspected / confirmed case of COVID-19 within the last 14 days.
- This test is for pre-admission screening or only considered unless clinically indicated.
 - Please consult our doctors for details.
- 請確保**過去14日沒有離開香港**；或**過去14日沒有**與2019冠狀病毒病懷疑/確診個案病人有密切接觸。
 - 完成強制隔離後**，本院會為閣下再安排入院/門診診症時間。
 - 豁免強制檢疫安排：**
豁免強制檢疫的人士包括機組人員：如病人過去14日曾離開香港及出現任何懷疑感染2019冠狀病毒病的徵狀(例如急性上呼吸道感染)，而又符合衛生防護中心的呈報準則，將會被轉介至公立醫院接受進一步診斷及治療。
 - 本院病理化驗中心獲香港特別行政區政府列為認可進行2019冠狀病毒病的醫療檢測指定機構，可提供「鼻咽拭子測試」(1)、「深喉唾液測試」及「抗體測試」(2)。
- 只適用於以下人士：
- 過去14日**沒有離開香港**
 - 過去14日**沒有**與2019冠狀病毒病懷疑/確診個案病人有密切接觸。
- 該測試只適用於入院前篩查，或在臨床情況下需要考慮使用。
 - 詳情請諮詢本院醫生意見。

2. Visiting Arrangements 探訪安排

- Each inpatient is limited to **4 visitors**, all visitors must have prior registration for visiting privileges and fill a health declaration form when arriving at the ward.
- Please **wear your own surgical masks**
- Visiting hours** : 10:30am – 1:30pm, 5:30pm – 8:30pm
- Visit limit: 2 persons** at a time, **please do not remove the mask and eat or drink during the visits.**
- Every visitor must scan the "LeaveHomeSafe" at the ward.
- People with illness, pregnant women and children **should avoid visiting hospital.**
- You are advised to **avoid visiting patients in ward** if you have a fever, or have close contact with patients with respiratory symptoms in countries/areas with the possible transmission of novel Coronavirus infection.
- Visitors of inpatients shall **provide a valid negative COVID-19 PCR test result obtained within 72 hours.**
- Visitors shall **provide negative COVID-19 PCR test results every 3 days for repeated or regular visits.**
- Our hospital reserves the right to execute any special arrangements for visitors and accompanying carers visiting our facilities without further notification.**
- 每位入院病人只限**4位**探訪者，所有訪客必須於探訪前提早登記資料，到訪時亦須填寫健康申填表。
- 訪客**請自備外科口罩**
- 探訪時段：**上午10時半至下午1時半、晚上5時半至8時半
- 探訪限制：**每位病人**每次2位**訪客，**探訪期間請勿除下口罩及飲食。**
- 探訪者須掃描病房外的「安心出行」二維碼。
- 患病人士、孕婦及兒童請**避免到醫院探訪。**
- 如果你有發燒徵狀，或曾經密切接觸來自可能傳播新型冠狀病毒地區或國家而有病徵的病人，**應避免前來探訪。**
- 探訪者必須**提供探訪前72小時內有效的新型冠狀病毒核酸檢測陰性化驗報告。**
- 重覆或定期進行探訪的人士，必須**每隔3天提供有效的新型冠狀病毒核酸檢測陰性化驗報告。**
- 本院保留一切有關訪客安排(包括探訪人士及照顧者)的最終決定權，包括隨時更改條款及細則，而毋須另行通知。

3. Gentle Reminder 溫馨提示

- Perform temperature check before visiting a hospital and monitor your health situation.
- Wash your hands before and after visiting hospital.
- You are required to wear surgical masks in hospital areas.**
- 請預先自行量度體溫，監察健康狀況。
- 進入或離開醫院時，請徹底清潔雙手。
- 醫院範圍內，必須佩戴外科口罩。**
